I. Call to Order Open Session:

Chairman Mel Webster called the meeting to order at 5:07 p.m.

Superintendent Bernard updated the committee on the opening of the 2017-2019 school year and discussed the preliminary in-district enrollment report taken from the first day of school. The official enrollment will be given at the October 16th meeting.

II. D.2. Fiscal Year 2019 North Reading Public Schools' Capital Improvement Plan Presentation

Each year the School Committee needs to review preliminary Large Capital Improvement project list for the school district and for the School Committee to begin to consider priority projects to move forward to the town's Capital Improvements Planning Committee (CIPC). Identification of priority projects is scheduled to take place at the September 25, 2017 School Committee meeting.

Michael Connelly, Director of Finance and Operations, reviewed the five-year plan, shared the history of the funded capital improvement projects over the last five years, and provided the rationale for fiscal year 2019 large capital needs.

Priority proposals from each department must be submitted to the CIPC by October 13, 2017. The Director of Finance and Operations will take the priorities set by the School Committee at this meeting and develop the CIPC proposals as required. The final proposals will be shared with the School Committee at the September 25, 2017 meeting at which time a vote to approve to submit should take place.
