I. Executive Session

At 6:44 p.m. the Committee voted on a motion by Mr. Webster and seconded by Mr. Bowers pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session for the purpose of discussing ongoing legal matters and school safety and security measures and to return to Open Session. Motion passed 5-0 on a roll call vote.

At 6:57 p.m. the Committee voted on a motion by Mr. Webster and seconded by Mr. Bowers to return to Open Session. Motion passed 5-0..

II. Call to Order Open Session:

Chairperson Ms. Janene Imbriano called the Open Session to order at 7:05 PM.

III. A. Public Input:

There was no public input.

III. B.1. MSBA/SSBC Update:

- a. Abatement of the former High School progressing well and building demolition is anticipated to begin in August
- b. Concrete work on the main entrance plaza continues
- c. Concrete work at the north (gymnasium) entrance continues

- d. Binder course paving has taken place at the Tennis Courts and Team Room (final course scheduled for late July/early August)
- e. Air balancing is ongoing; progressing towards F building
- f. Air Handler units start-up has begun. Four of six units are operational
- g. Interior casework is close to completion; work is currently taking place in the science classrooms
- h. Punchlist work continues in the High School and E 2 story building 2nd floor was "punched" on July 20th. Remaining portions of the Middle School building will be "punched" in stages over the next three weeks.
- i. Floors in Middle School are being waxed
- j. The next SSBC meeting is July 28, 2015.

III. C.1. Dr. Patrick Daly, Assistant Superintendent – PARCC Review

Dr. Daly provided a presentation that recaps the administration of the PARCC test this past school year. Dr. Daly also reviewed locally collected survey data and other relevant information as it relates to PARCC.

III. C.2. North Reading Middle School French Club Proposal

Superintendent Bernard presented a proposal for a French Club at the Middle School.
