At 6:30 p.m. the Committee voted on a motion by Mr. Webster and seconded by Mr. Bowers pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session to discuss contract negotiations with the Food Services employees as well as members of the Administration and to reconvene in Open Session. Motion passed 5-0 on a roll call vote.

Chair Janene Imbriano called the Open Session to order at 7:06 PM.

Nicolas O'Connell, Class of 2016 provided the student report and presented his class work.

#### II. D.1. Presentation: J.T. Hood Elementary School Faculty and Students

This was the fourth of the five school presentations made to the School Committee in the 2015-2016 school year. Mr. Glen McKay, Principal, and members of the J.T. Hood Elementary School faculty and students provided a presentation to the School Committee.

## II. D.2. Presentation: Digital Learning Program Superintendent's Student Learning Goal

Dr. Daniel Downs, Digital Learning Coordinator for the North Reading Public Schools provided an informational presentation/update on the Digital Learning Program that is occurring across the school district and which was introduced at the start of the 2015-2016 school year.

## II. D.4. Presentation: Pilot - Kindergarten Full-Day/Half-Day Hybrid Model

Superintendent Bernard and Michael Connelly provided a presentation on a model for a full-day/half-day hybrid for Kindergarten students at the E. Ethel Little Elementary School for the 2016-2017 school year.

The Committee voted on a motion by Mr. Venezia and seconded by Mr. Bowers to approve a Pilot Program for the E. Ethel Little Elementary School, full-day/half-day Kindergarten program. Motion passed 5-0.

## C.1. MSBA/SSBC Update:

- a. Backfilling of the softball field to subgrade has begun in preparation of the drainage installation
- b. Breaking of ledge at the site of the former high school is approximately 40% complete
- c. Installation of drain lines continues at the site of the former high school (run from manhole under SW parking lot to area drain between discus and softball field)
- d. The chain link fabric at the new athletic field has been installed
- e. Punch list work continues (a meeting was held with school administration on March 11, 2016.
- f. AV equipment training (round two) scheduled for March 24, 2016
- g. The next SSBC meeting is scheduled for April 12, 2016.

## II. D.3. Invitation to Participate: Springfield College Physical Education and Health Education Study

Superintendent Bernard introduced an invitation to participate in a Physical Education and Health Education Study extended by Springfield College. Ms. Claudia Brown, Curriculum Specialist for Health and Physical Education for the North Reading Public Schools, will elaborate on the invitation and its value.

The Committee voted on a motion by Mr. Webster and seconded by Mr. Venezia to enable the Little School to participate in the Springfield College Physical Education and Health Education Study, contingent with the request that a consent form be obtained from each student. Motion passed 5-0.

Superintendent Bernard presented a proposed amendment to the Collaborative Agreement of the Northshore Education Consortium. This proposed amendment has received the endorsement of the Northshore Education Consortium's Board of Directors, of which the Superintendent is a member, through two readings at public meetings.
