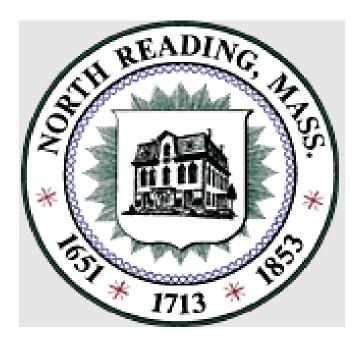

RE: F/Y 2017 Capital Acquisition Recommendation

This year's deliberations by the Capital Improvement Planning Committee (CIPC) were longer in duration than those of the past due to several factors, including the reorganization within the town DPW, a developing situation in the Stormwater Permits issued by the EPA and a late request to consider bathroom facilities at the High School football field. As in the past requests were presented in writing by the various town department heads to the Finance Director. The Committee met with those requesting the capital items and where appropriate conducted field trips to examine the equipment or vehicles proposed for replacement. The requests covered F/Ys 17, 18 &19. The Committee met on several occasions to discuss each of the requests before we individually ranked each item.

The initial list of requests included 33 items totaling more than \$2.8m, not including the late request for the bathroom facilities at the football field. Early in the process several items were eliminated or withdrawn because they were repair and maintenance items that belong in the operating budget rather than in the capital budget. The School Department also withdrew its request to fund wireless infrastructure in the elementary schools in order to evaluate grant possibilities and bring it back to the CIPC next year. Several DPW initiatives were also withdrawn pending the reevaluation of the department. We expect that several of these requests will come back next year. As shown on the attached Ranking Sheet, we ended up with 16 requests totaling \$1.9m. We are recommending 10 items with a total value of \$665k.

We are proposing spending \$200k this cycle on improvements to the fire station primarily to improve the living conditions at the station. The committee was presented with Space Study Report on the Fire Station which, if acted upon, would cost nearly \$5m. We recognize that this is not affordable, but our site visit impressed on everyone that we have to improve living conditions for the firefighters.

It has been the goal of the Committee to decrease the Town's dependence on bonding of short duration items (5 year bonding). To that end, we are proposing to withdraw funds from the Capital Improvement Stabilization Fund (\$96k in f/y 17 and \$50k each subsequent year) to augment the funds from June Town Meeting in order to pay cash for all 5 year items. There will be one 5 year item (WiFi upgrade for town facilities-- \$70k) bonded from this year's recommended list because the Stormwater request is not bonding eligible and will require the use of \$105k in cash, essentially consuming the balance of available cash.

Looking down the road, there are several big ticket items on the horizon that will, if approved, put a strain on capital program and the resulting debt service.

In 2018 there is a request for a replacement fire engine (\$525K), the bathroom facilities at the football field, the scope and amount are unclear, but could approach \$500k and a possible \$225k item for the design and permitting of a \$1.9m project to connect town buildings in the center to the waste water treatment plant at the high school. There will be a needs assessment undertaken of the current septic systems at those buildings to determine when or if we need to do the hookup to the WWTP. The 2019 capital request will likely include the replacement of another fire engine at an

The 2019 capital request will likely include the replacement of another fire engine at an estimated cost of \$500k.

The committee appreciates the support of the Board of Selectmen in continuing to recommend the Free Cash and Budget Appropriation so that there is a dependable source of funds allocated to the much needed capital projects. Because of this support, we feel comfortable in funding the 5 year items in cash, giving us more flexibility to consider longer term projects and maintain a stable annual debt service obligation. The plan requires that the Town make the following fiscal commitment:

Increase the \$150,000 in the current Operating Budget to the Capital Improvement Stabilization Fund (CISF) by \$25,000 in each succeeding year until we reach a steady state of \$200,000 in f/y2021

Dedicate \$150,000 of Free Cash to the CISF at the annual June Town Meeting. Dedicate \$200,000 of Free Cash to the CISF at the annual October Town Meeting.

There are 6 items from the Water Enterprise totaling \$1.4m. Most of these items relate to the planned move to MWRA. The committee is recommending all of the proposed requests. There were no requests from the other two Enterprise Funds, Hillview Commission or Parks & Recreation.

The Committee's work will continue over the next several months prioritizing the F/Y 18 and 19 items as well as the F/Y 17 requests that could not be recommended at this time because of funding limitations.

We would like to thank the department heads for their cooperation and help in developing North Reading's capital plan.

Description

TThe 2005 special education van was approved in FY'16 for replacement with capital funds and transferred to the Food Service Department. The district currently utilizes three special education vans daily to transport students between in town special education programs. The 2007 special education van is currently used as a spare and is also used to transport athletic teams and activities when appropriate, which has helped reduce athletic transportation costs. The District capital request involves a replacement plan to replace the 2006 and 2007 vans over the next two vears.

Justification

The next van in need of replacement is the 2006 wheel chair van, this van has over 120,000 miles on it and must be special outfitted to accommodate the transportation of students in a wheel chair.

Having a well equipped and reliable vehicle to safely transport students to and from programs on a daily basis is essential. This will ensure the Special Education Department can safely transport students and has an appropriate spare vehicle on hand in the event of emergencies.

Impact

Inaction raises the possibility of a vehicle breakdown which would compromise our ability to safely transport our students with special needs. A special education vehicle would improve our ability to transport student safely and maintain the students routine and schedule.

Description

This project will implement the results of the 2014 Town of North Reading Water Conservation Master Plan. The Plan evaluated all Town & School Buildings relative to water use & examined costs to improve water use efficiency (reduced operating costs).

Justification

1. As part of the Town's ongoing water & wastewater projects, the Town would have to comply with the Commonwealth of Massachusetts Water Conservation Standards. One part of these requirements is to implement water conservation devices in all municipal buildings. 2. sixty six percent (66%) of these projects have less than a 2.5 year Rate of Return.

Impact

Lack of action will adversely affect water & wastewater project environmental permitting and cause excessive costs

Description

The District over the last three years has been able to increase our capacity to incorporate many mobile devices (iPads, Chromebooks, tablets, etc.) into our educational plans. Each device has it's benefit to enhance the educational experience and function as a tool for learning. In order to meet our Digital Learning goals our schools need additional devices in order to meet the needs of the students. The District has worked on an on-going computer/device replacement plan which includes replacing devices as they reach the end of their useful life and continuing to add devices to increase the student to computer ratio. Budgeting an annual amount for computer replacement will allow the school district to meet its goals for digital learning. The District has received \$60,000 each of the last two years where it has been able to purchase additional Chrome book carts at each elementary school.

Justification

The current devices were purchased in 2006 or earlier. These devices are running specifications that are not sufficient for the software and programs we are attempting to utilize in our classrooms. Furthermore, as we will be required to upgrade from Windows XP when it is no longer supported by Microsoft, these devices will not be able to be upgraded.

Description

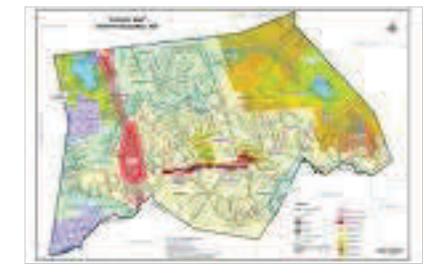
Continue to upgrade the existing digital drain map for the town. One requirement of the USEPA Phase II storm water permit is to have an accurate drain map. Our current map does not meet this requirement. The work funded at the fall 2012 town meeting is locating & inspecting all drain manholes and catchbasins, and then importing into the drain layer of the town's GIS. This next phase address drain systems requiring additional inspection, and the inspection of all culverts & outfalls.

Justification/Impact

- 1. Federal regulatory requirement from 2003 MS4 permit
- access to current, accurate digital information; more efficient performance of daily duties
- 3. Reduction or elimination of data redundancy among departments, decrease operating costs
- 4. Improved accuracy of existing

Description

There is currently no physical connection between the North Reading and Reading water systems. This connection is needed to receive water from MWRA.

WATER DISTRIBUTION IMPROVEMENTS- WATER MAIN REPLACEMENT ACCEPTED STREETS

Description

Replace undersized or outdated water mains in streets to be reconstructed under the Town's Road Improvement Program, or as identified by the 2014 Water Master Plan

Justification

The water mains in such streets would be assessed in terms of age, material, construction, size and hydraulic benefit to the water distribution system as a whole. The Town's water distribution system consists of approximately 80 miles of water main, three water storage tanks, 750 fire hydrants and 4,800 water services installed from 1936 to the present. These components are all subject to physical degradation, and each component has a useful lifespan. This project is to fund the replacement of components – hydrants, gate valves, water services and water main – that has reached the end of its useful life. The goal is to have a distribution system that continues to function without an interruption of service to the residents and businesses supplied by that system: fire hydrants that can be relied on when needed, gate valves that will shut off water mains during a water main break, water services that continually supply water to individual homes and businesses.

This project also is implemented in conjunction with the Town Road program, by undertaking replacements of water system components prior to the roadway reconstruction. This project is not specifically identified as a need in the Water System Master Plan, as the timely replacement of outdated components falls more in

Description

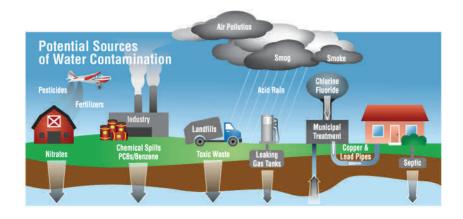

Justification

2013 total coliform issue & 2014 TTHM issues revealed this issue, significant public safety impacts if E.coli water contamination occurs due to disinfection issues. Also critical re dealing with chloramination disinfection of a "sequential" MWRA community. Scope TBD but may include water tank mixers, supplemental disinfection ports in the water distribution system, etc.

Impact

Ensures that water meets all Federal and State Standards.
