# I. Call to Order Open Session

Chair Scott Buckley called the Open Session to order at 6:00 pm.

#### **Executive Session**

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. McGowan pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to enter into Executive Session to discuss the North Reading Education Association Side Letter of Agreement, and to return to Open Session. Motion passed 5-0 on a roll call vote.

Chair Buckley called the Open Session back to order at 6:31 pm.

**II. A. Public Input:** There was no public input.

#### II. B. Student Report:

Ms. Shivani Srikanth, Class of 2022, shared the student report.

# II. E.4. Bids and Donations:

• International Family Church: \$40,000.00 donation to improve the educational experience.

Pastor Jonathan Del Turco attended the virtual meeting and spoke of how he and the church are pleased to be able to make this donation to their local school district.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to accept with overwhelming gratitude a generous donation of \$40,000.00 from the International Family Church and Jonathan and Verna Del Turco to be used at the District's discretion to improve the educational experience for all students at North Reading Public Schools. Motion passed 5-0 on a roll call vote.

 North Reading Diamond Club: \$5,298.53 donation for NRHS baseball field improvements and scoreboard.

Mr. Chris Hanson and Mr. Tim Haynes from the North Reading Diamond Club were present at the meeting to receive the North Reading School Committee gratitude.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to accept with gratitude a generous donation of \$5,298.53 from the North Reading Diamond Club to be used to fund NRHS baseball field improvements such as a scoreboard project and dugout repairs at the North Reading High School. Motion passed 5-0 on a roll call vote.

# II. D.1. North Reading High School Presentation:

Mr. AJ Loprete (Principal, NRHS) led a student and staff showcase of student learning and updates from NRHS. Tonight was the first of the five school presentations to be made to the School Committee in the 2020-21 school year.

#### II. C.1. Hybrid Learning:

Dr. Daly addressed updates on the progress of our schools in the 2020-21 school year in the hybrid model. Updates included communication about the COVID-19 testing, school data, the hybrid model, and other related topics.

# II. D.2. High School Athletics Update:

Mr. Loprete (Principal, NRHS) and Mr. Dave Johnson (Athletic Director, NRHS) presented an update on High School Athletics, including a timeline and update on the winter and wedge seasons. The Committee discussed the topic of public attendance at school events, in and outside of the schools, and decided it was an administrative decision.

# II. D.3. 2020-2021 School Calendar Updates:

Dr. Daly presented updates and modifications to the 2020-21 school year calendar.

- --Wednesday, January 27<sup>th</sup> will be a half day **for elementary only**. Since this is also the scheduled day for elementary collaboration there will be opportunities for educator collaboration as well as other district offerings for professional development that day. Elementary paraprofessionals will participate in the district offerings.
- --Tuesday, April 13<sup>th</sup> will be a half day **for middle and high school only** as this is the opportunity for us to provide the SAT for North Reading students. There will be district offerings for paraprofessionals and educators 6-12, although there will be a need for some high school educators to assist with the SAT proctoring to provide this opportunity for students.

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. McGowan to amend the 2020-21 school calendar to change January 27, 2021 be a half day for elementary only a full day for middle and high school, and April 13, 2021 to a half day for middle and high school and a full day for elemental). Motion passed 5-0 on a roll call vote.

## II. D.4. COVID-19 Pool Testing:

Dr. Daly presented an overview of a pool testing initiative and the upcoming opportunity from the Department of Elementary and Secondary Education. Dr. Daly also gave an update of the North Reading School District's COVID-19 numbers and actions.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Boutwell to have the Superintendent move forward with next steps on pool testing. Motion passed 5-0 on a roll call vote.

# II. C.2. First Reading: Policies GAE, GCH, and KN

The School Committee reviewed first readings of different policies.

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. Pappavaselio to approve the revised reading of Policy GAE and to keep the "track changes" as delineated in the document. Motion passed 5-0 on a roll call vote.

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. Pappavaselio to approve the revised reading of Policy GCH and to keep the "track changes" as delineated in the document. Motion passed 5-0 on a roll call vote.

<u>The Committee voted on a motion by Ms. Imbriano and seconded by Mr. Pappavaselio to approve the revised reading of Policy KN and to keep the "track changes" as delineated in the document. Motion passed 5-0 on a roll call vote.</u>

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. McGowan to disband the Superintendent Search Committee. Motion passed 5-0 on a roll call vote.

#### II. D.10. NREA Side Letter of Agreement

The School Committee reviewed the Side Letter of Agreement with the North Reading Education Association relating to the extended definition of bereavement leave.
