I. Call to Order Open Session

Chair Scott Buckley called the Open Session to order at 6:30 pm.

- **II. A. Public Input:** There was no public input.
- II. B. Student Report:

Ms. Shivani Srikanth, Class of 2022, shared the student report and her class work.

II. D.1. Presentation: Representatives of the Northeast Metropolitan Regional Vocational High School

Dr. David DiBarri, Superintendent-Director of the Northeast Metropolitan Regional Vocational High School; Ms. Judy Dyment, North Reading's Representative to the NEMRVHS; Mr. Jay Picone, Finance Director; and Ms. Carla Scuzzarella, Deputy Director/Principal, discussed the school's response to Hybrid Learning and the plans for the building of a new school.

II. D.2. Community Impact Team (CIT) Survey

Ms. Amy Luckiewicz, (CIT), and Dr. Daly reviewed the CIT annual survey, about healthy behaviors and well-being, to be taken by secondary students in the coming weeks. This is the fifth and final year of the Drug Free District Grant ending in September 2021. The Community Impact Team will apply for another five-year grant.

The Committee voted on a motion by Ms. Imbriano and seconded by Ms. Boutwell to approve the Community Impact Team survey for the Middle and High School.

Motion passed 5-0 on a roll call vote.

II. C.1. 2020-21 School Year Update:

Superintendent Daly provided updates on the progress of our schools in the 2020-21 school year in the hybrid model. Updates included communication about the COVID-19 testing, survey data, plans for a return to full in-person, school start times, and other related topics.

II. D.3. 2021-22 School Calendar

Dr. Daly presented the first draft of the 2021-22 school calendar to include a start date for the year as well as an anticipated end date. There is also an addition of a new State holiday in recognition of Juneteenth.

II. D.4. School Start Times Update

Dr. Daly gave an update on the work of the School Start Times Committee and the timeline for a presentation to the North Reading School Committee.

II. D.5. FY22 Preliminary Budget Presentation

Mr. Michael Connelly, Assistant Superintendent of Finance and Operations, reviewed the Fiscal Year 2022 preliminary budget.

II. D.6. Facilities Master Plan Committee

The North Reading School Committee nominated Mr. McGowan as a member to the Facilities Master Plan Committee through May 2021. In May at the reorganization another nomination will be made.

<u>The Committee voted on a motion by Ms. Imbriano and seconded by Ms. Boutwell to appoint Mr. McGowan to the Facilities Master Plan Committee. Motion passed 5-0 on a roll call vote.</u>

II. D.7. Secondary Schools Building Committee

The North Reading School Committee recommended the appointment of Mr. Scott Buckley, Mr. Sonny Campagna, and Dr. Patrick Daly to the Secondary Schools Building Committee (SSBC) to replace those no longer serving the district. Mr. Chuck Carucci, Chair of the SSBC, has suggested the appointments include (1) an additional School Committee member to serve along with Ms. Imbriano, (2) Dr. Daly to serve as the Superintendent representative, and (3) Mr. Campagna to serve as the Facilities Director. A joint meeting of the Select Board and School Committee will be necessary to vote to approve these appointments.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to appoint Dr. Daly to serve as the Superintendent representative, Mr. Campagna to serve as the Facilities Director, and Scott Buckley to serve as an additional School Committee member on the side. We recommend that the Joint Select Board and the School Committee appoint those three. Motion passed 5-0 on a roll call vote.

II. D.8. Second Reading: Policy JHFB-R

The School Committee reviewed the second reading of policy JHFB-R.

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. Pappavaselio to approve the second reading of Policy JHFB-R and to keep the "track changes" as delineated in the document. Motion passed 5-0 on a roll call vote.

II. D.9. Superintendent's Evaluation Update: Formative Assessment

Mr. Pappavaselio shared the School Committee's Formative Assessment of Dr. Daly.

Mr. Connelly, Assistant Superintendent of Finance and Operations gave a student activity report for the second quarter of the fiscal year reflecting activity through December 31, 2020 for each school student activity account.
