I. Call to Order Open Session:

Chair Scott Buckley called the Open Session to order at 6:33 pm.

II. D.1. 2021 Retiree Recognition

II. D.2. NREA Contract

The North Reading School Committee and the North Reading Education Association (NREA) have reached a tentative agreement as a result of collective bargaining negotiations held from March to June 2021. The NREA held a ratification meeting with their membership on Monday, June 14, 2021 and voted in the affirmative to approve the terms of the tentative agreement.

In general, the terms of the tentative agreement are as follows:

- The contract will be for three years, July 1, 2021 through June 30, 2024;
- The cost-of-living adjustments (COLA) are 3.0%, 2.5%, 2.5% in fiscal years 2022, 2023, and 2024 respectively;
- A revised curriculum leadership stipend schedule will be instituted to provide great equity across all three levels;
- Adjustments were made to the language to adjust for the start times changes at all levels;
- Updates were made to the language for part-time educators and those working at multiple schools.

The negotiations sessions were conducted virtually, and the tone was professional and collaborative throughout. Dr. Daly, Mr. Connelly, Mr. Buckley, and Mr. McGowan said it was a pleasure working with all members of this team and to witness everyone's commitment to improving our district. Mr. Buckley and Mr. McGowan both of whom represented the School Committee, acted in ways that were fiscally responsible and forward thinking.

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Pappavaselio to approve the contact with the NERA that runs July 1, 2021 through June 30, 2024. Motion passed 5-0 on a roll call vote.

Dr. Daly addressed the miscommunication about stipends paid for post season sports this year.

II. D.5. NRPS Performing Arts Trip 2022:

The Committee voted on the NRHS Performing Arts Trip, April 26 through May 1, 2022 which was presented to the Committee at the previous meeting.
