# I. Call to Order Open Session

#### II. D.2. North Reading High School Overnight Trip to Quebec

# II. D.3. Food Service Contract Side Letter of Agreement

The North Reading School Committee previously approved the side letter of agreement that increased food service hourly wages effective January 1, 2022 by a rate of \$1.25. Administration requested a formal public vote to acknowledge this acceptance and contract amendment.

Mr. Buckley and Mr. Connelly will continue to be the School Committee representative in the upcoming Food Services contract negotiations.

The Committee voted on a motion by Ms. Imbriano and seconded by Ms. Boutwell to approve the Side Letter of Agreement dated December 3, 2021 to amend provisions of the Food Service Worker Contract reached for FY20-FY22 effective January 1, 2022 as recommended by the Administration. Motion passed 4-0.

- Mr. Killeen is leading the Standards Based Report Card Committee, which will work to review and align report cards with the curriculum standards.
- Mr. Matt Costello shared with Mr. Loprete and Dr. Daly his work on the One Love Foundation: Learn to Love Better, which is a non-profit with the goal of ending relationship abuse. One Love is a National Association named for Yeardley Love a college student whose life was cut short by an abusive boyfriend. - The District was awarded several grants that were applied for months ago. Among the grants is the Financial Literacy Grant for \$14,400.00 for staff to develop curriculum for K-12 on financial literacy.
