I. Call to Order Open Session:

Chair Cliff Bowers called the Open Session to order at 6:32 PM.

II. A. Public Input:

II. B. Student Input:

II. C.1. MSBA/SSBC Update:

- a. Coils on AHUs #2 & #16 replaced on September 1st and 2nd.
- b. Manafort has measured the elevations of the walkway in the southwest corner of the waste water treatment plant parking lot and is determining a solution to making the grade accessibility compliant.
- c. Manafort has begun performing additional mandrel blade tests and is evaluating the lines that failed.
- d. Manafort is planning on digging up a drainage line (week of September 12th) in the parking lot near the waste water treatment plant in order to examine the joints and try and determine a "game plan" for moving forward with addressing the drainage lines.
- e. Light control mechanism at the tennis courts was installed on September 9th.
- f. Punchlist items continue to be addressed
- g. The next SSBC meeting is scheduled for September 20, 2016.

II. D.1. Report: Opening Day

Superintendent Bernard gave a report on the opening to the 2016-2017 school year. A preliminary in-district enrollment report taken from the first day of school was reviewed.

II. D.2. Second Reading: Policy EEC - "Food Services Management: Student Meal Assistance"

The Committee reviewed and approved the second reading of Policy EEC - "Food Services Management: Student Meal Assistance"

II. D.4. Proposal: Central Office Receptionist/Business Office Support Personnel

Superintendent Bernard and Michael Connelly (Director of Finance and Operations) reviewed the proposal to add the position of Central Office Receptionist/Business Office Support Personnel. After review of the funding for this position, the Committee was in consensus in this position being filled.

II. D.5. Fiscal Year 2018 North Reading Public Schools' Capital Improvement Plan Presentation

Michael Connelly (Director of Finance and Operations) reviewed the preliminary large capital improvements project list for the school district and the proposed priority of the projects to move forward to the town's Capital Improvements Planning Committee (CIPC).

Mr. Connelly reviewed the five-year plan, provided the rational for fiscal 2018, and shared the history of the funded capital improvement projects over the last five years.

Priority proposals from each department must be submitted to the CIPC by September 30, 2016. The final proposals will be presented and voted on at the September 26, 2016 School Committee meeting.
