I. Call to Order Open Session:

Chairman Mel Webster called the meeting to order at 5:40 p.m.

Executive Session:

The Committee voted on a motion by Ms. Imbriano and seconded by Ms. Koepke pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to enter into Executive Session to review collective bargaining strategies with the North Reading Education Association, and also to discuss the Superintendent's employment contract, and to return to Open Session. Motion passed 5-0 on a roll call vote.

At 6:28 p.m. the Committee voted on a motion by Ms. Imbriano and seconded by Mr. Buckley to return to Open Session. Motion passed 5-0 on a roll call vote.

II. Call to Order Open Session:

Chair Mel Webster called the Open Session back to order at 6:35 p.m.

III. A. Public Input:

There was no public input.

III. B. Student Input:

Mr. Michael Tyrell gave the student report and presented a sample of his class work.

At 6:42 p.m., the Committee voted on a motion by Ms. Imbriano and seconded by Mr. Buckley to open the FY19 Public Budget Hearing. Motion passed 5-0.

III. D.1 Fiscal Year 2019 Public Budget Hearing: School Committee Goal FCR-III-B-1 Superintendent's Professional Practice Goal Superintendent's District Improvement Goal #1

At the meeting of the Finance Planning Team on April 3, 2018, available revenue was identified that indicates the school department's budget gap is currently at \$482,522 for the "Recommended Budget" and \$234,014 for the "Level Services Budget."

Mr. Michael Connelly reviewed the "Recommended Budget" for Fiscal Year 2019, which represents a \$1,564,988 or 5.3% increase over the Fiscal Year 2018 budget appropriation. The "Level Services Budget" for Fiscal Year 2019 represents a \$1,316,480 or 4.4% increase over the Fiscal Year 2018 budget appropriation.

After the presentation, Mr. Connelly opened up the meeting for public input/questions from the School Committee and residents in the audience. On April 27, 2018, the School Committee will hold a second FY19 Budget Workshop after meeting with the Finance Planning Team on April 25, 2018. The final budget to be presented at Town Meeting will be voted on April 30, 2018 at the next School Committee Open Session Meeting.

Below are samples of the questions asked from residents at the meeting:

Ms. Loretta Capezzuto – Asked what is the dollar amount of the 1.30 % increase in the Special Education Out-of-District costs? (\$422,000)

Ms. Darcy Favorite – Asked if the district has control of where the contractual services monies are spent?

Mr. Andy Schultz (NR Selectman) – Gave input on the future income from the new Pulte Homes Project.
