I. Call to Order Open Session:

Chairman Mel Webster called the Open Session to order at 5:40 p.m.

Executive Session:

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. Venezia pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to enter into Executive Session to review collective bargaining strategies with the North Reading Education Association. Motion passed 4-0 on a roll call vote.
