I. Call to Order Open Session:

Chair Janene Imbriano called the Open Session to order at 6:30 PM.

II. B. Student Report:

Ms. Samantha Galvin gave the student report and presented a sample of her class work.

II. D.1. Presentation: Ms. Amy Luckiewicz; Drug Free Communities Grant/Core Measurements Survey Results

Ms. Amy Luckiewicz, Drug Free Communities Grant Coordinator, presented the results of the Core Measurements Survey administered to students in grades 6-12 in the spring of 2018. Ms. Luckiewicz also gave a presentation and answered questions regarding “vaping” and the efforts of the community to combat this disturbing trend.

II. D.2. School Committee Policies: First Reading

Policy BCBI: Procedure to be Followed by Public In Placing Items on School Committee Agenda was tabled for further revision and vote at a future meeting of the School Committee.

Policy BH: Code of Ethics

The Committee voted on a motion by Ms. Boutwell and seconded by Mr. McGowan to approve the first reading of the revised Policy BH – Code of Ethics. Motion passed 5-0.

II. E.1 Minutes: No minutes at this time.**II. E.2. Budget Update:**

Mr. Michael Connelly, Director of Finance and Operations, reviewed the Student Activity Quarter 1 Report which reflects activity through September 30, 2018

The Committee voted on a motion by Mr. Webster and seconded by Mr. Buckley to approve the list of active student activity accounts at the High School and Middle School for the 2018-2019 school year as presented by the administration. Motion passed 5-0.

Mr. Connelly also proposed an additional item to be included among the capital improvement projects for the district to be submitted to the Capital Improvements Planning Committee for consideration for funding in Fiscal Year 2020. The project is compliance upgrades to the softball field complex at North Reading Middle/High School needed to fully complete the project and bring the field's amenities to an appropriate level consistent with other athletic complexes available to student athletes. These upgrades would include the supply and installation of rooftop dugout enclosures and the supply and installation of an electronic scoreboard. This cost is not to exceed \$35,000.00

The Committee voted on a motion by Mr. Webster and seconded by Mr. Buckley to submit the scoreboard dugout enclosure project request to the CIPC. Motion passed 5-0.

Superintendent Bernard requested the acceptance of the following donations:

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Buckley to accept with gratitude a donation of \$100.00 from Nancy and John Meaney to offset expenses associated with the High School Cross Country Track Team. Motion passed 5-0.

- Hood Elementary School Parents' Association; \$240.00 donation to offset costs for the Hood Elementary School's STEAM night.

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Webster to accept with gratitude a donation \$240.00 from the Hood School Parents' Association to offset costs for the Hood Elementary School's STEAM night. Motion passed 5-0.

- Little School Parents' Association; \$300.00 donation to support transportation costs associated with the Boston Symphony Orchestra field trip.

The Committee voted on a motion by Mr. McGowan and seconded by Mt. Buckley to accept with gratitude a donation of \$300.00 from the E. Ethel Little School Parents' Association to support transportation costs associated with the Boston Symphony Orchestra field trip. Motion passed 5-0.

- Multiple donations through Snap Raise online fundraising; \$2,982.85 donation for the NRHS Boys Soccer Team.

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Webster to accept with gratitude a donation of \$2,982.85 collected from Snap Raise through online fundraising to offset the High School Boys Soccer team expenses. Motion passed 5-0.
