I. Call to Order Open Session:

Chair Janene Imbriano called the Open Session to order at 6:30 PM.

II. A. Public Input:

II. B. Student Report:

Tonight is Mr. Michael Tyrrell's last presentation to the School Committee. He thanked the North Reading School Committee past and present for all they have done for the schools during his twelve years in the district. He then presented the Student Report to the School Committee and his class work.

The Committee voted on a motion by Mr. Buckley and seconded by Mr. McGowan to open the meeting for a Public Hearing for the purpose of reviewing the Fiscal Year 2020 Budget at 6:39 PM. Motion passed 4-0.

II. D.1. Fiscal Year 2020 Budget Presentation Superintendent's Professional Practice Goal

Mr. Michael Connelly, Director of Finance and Operations presented the updated budget for FY20.

At the meeting of the Finance Planning Team on April 3. 2019, available revenue was identified that indicates the school department's budget gap is currently at \$401,614 for the "Recommended Budget" and \$207,643 for the "Level Services Budget."

The "Recommended Budget" for Fiscal year 2020 represents a \$1,337,273 or 4.3% increase over the Fiscal Year 2019 budget appropriation. The "Level Services Budget" for Fiscal Year 2020 represents a \$1,143,302 or 3.7% increase over the Fiscal Year 2019 budget appropriation.

Mr. Connelly answered Mr. Kelliher's (NR Resident) question: "of the two operational items, are they net of the anticipated savings?"

The Committee voted on a motion by Mr. Buckley and seconded by Ms. Boutwell to close the Public Hearing on the Fiscal Year 2020 Budget at 7:33 PM. Motion passed 4-0.

Ms. Felicia Linehan, French teacher at North Reading High School, proposed a trip to Quebec for High School students for November 14-16, 2019.
