## I. Executive Session

At 6:03 p.m., the Committee voted on a motion by Mr. McGowan and seconded by Mr. Buckley pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session for the purpose of conducting strategy sessions in preparation for negotiations with non-union personnel. Motion passed 4-0 on a roll call vote.

At 6:30 p.m. the Committee voted on a motion by Mr. Buckley and seconded by Mr. McGowan to return to Open Session. Motion passed 4-0 on a roll call vote.

#### C.1. School Committee Policies; Second Reading School Committee Goal FCR-III-A-1 Superintendent's Professional Practice Goal

Policy EDAA: Use of School Vehicles

<u>The Committee voted on a motion by Mr. Buckley and seconded by Mr. McGowan to</u> approve the second reading of Policy EDAA – Business Management – Use of School Vehicles. Motion passed 4-0.

# II. D.1. Proposal: North Reading High School Performing Arts Trip; Disney World (Spring 2020)

Ms. Allison Kane, Performing Arts teacher, proposed a trip to Disney World for high school students from April 29, 2020 – May 3, 2020.

*The Committee voted on a motion by Mr. Buckley and seconded by Ms. Boutwell to endorse the NRHS Trip to Disney World, April 29, 2020 – May 3, 2020. Motion passed 4-0.* 

## II. D.2. Presentation: Grade 5 Health and Sexuality Curriculum Superintendent's Professional Practice Goal

Dr. Patrick Daly, Assistant Superintendent, proposed an update to the Grade 5 Health and Sexuality Curriculum. The video used in this class will be updated to make it more relevant for students today. Girls and boys would view the video in class together rather than segregated by sex. Parents will have the opportunity to view the video prior to it being shown to the students, with an opt-out option.

The Committee voted on a motion by Mr. Buckley and seconded by Mr. McGowan to accept the Grade 5 Health and Sexuality Curriculum update. Motion passed 4-0.

#### II. D.3. Fiscal Year 2020 Budget Vote School Committee Goal FAM-III-A-1 Superintendent's Professional Practice Goal Superintendent's District Improvement Goal #1

Mr. Connelly, Director of Finance and Operations, and Superintendent Bernard presented the Fiscal Year 2020 proposed budget. The School Committee approved budget will be presented at the June 3, 2020 Town Meeting.

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Buckley that the School Committee approve and hereby adopt the FY'20 School Operating Budget of \$31,757,773; this represents an increase of 3.3 % or \$1,011,726 over FY'19. Motion passed 4-0.

# II. D.4. School Choice Public Hearing

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Buckley to open the Public Hearing for the purpose of discussing and voting on School Choice at 7:46 pm. Motion passed 4-0. Under the Education Reform Act of 1993 there is a need to hold an annual public hearing on School Choice. Becoming a Choice District means that North Reading will accept students from other cities and towns for enrollment in its schools. Once a student is accepted as a choice student, he or she is a student until graduation or the student opts to withdraw. The district receives an additional \$5,000.00 from the sending district's Chapter 70 funds for each student accepted. A brief discussion followed.

The Committee voted on a motion by Ms. Boutwell and seconded by Mr. McGowan that North Reading School District not participate in School Choice because the program as it is presently constructed ensures that the needs of some of the children of the Commonwealth cannot be met. Motion passed 4-0.

The Committee voted on a motion by Mr. McGowan and seconded by Mr. Buckley to close the Public Hearing on School Choice at 7:49 pm. Motion passed 4-0.

## D.5. School Committee Self-Evaluation 2018-2019 School Committee Goal LG-III-C-1 Superintendent's Professional Practice Goal

Mr. McGowan presented the School Committee's 2018-2019 composite self-evaluation results and facilitated a discussion about the use of these results during a goal setting workshop to be held in the summer.
