I. Call to Order Open Session:

Chair Scott Buckley called the Open Session to order at 6:36 PM.

II. A. Public Input:

There was no public input.

II. B. Student Report:

Ms. Bridget Grew, Class of 2020, presented the Student Report to the School Committee and presented her class work.

II. D.1. Special Recognition

Invitations were extended to Middle School and High School retirees to attend the School Committee meeting to be publicly recognized for their service to the school district. Tonight Mr. Nick Damiano (NRMS), Ms. Robyn Forman (NRHS), Ms. Suzanne Passeri (NRHS), and Ms. Rose Stadig (NRHS) were acknowledged.

In addition, State Representative Brad Jones and his son, Nicholas Jones, received "Certificates of Appreciation." Representative Jones facilitated the acquisition of \$250,000 in state funds in Fiscal Year 2019 to support: school safety and security measures (\$175,000), and technology acquisitions (\$75,000). In addition, through his son Nicholas' urging, Representative Jones has provided two POW-MIA flags to be displayed proudly at North Reading Middle School and North Reading High School.

II. D.2. Presentation: School Improvement Plans; NRMS and NRHS

Dr. Catherine O'Connell (NRMS Principal) and Mr. AJ Loprete (NRHS Principal) reviewed the progress made to achieve their 2018-2019 School Improvement Plan goals and presented the 2019-2020 School Improvement goals.

The Committee voted on a motion by Mr. Pappavaselio and seconded by Mr. McGowan to accept the 2019-2020 North Reading High School Improvement Plan. Motion passed 5-0.

<u>The Committee voted on a motion by Mr. Pappavaselio and seconded by Mr. McGowan to accept the 2019-2020 North Reading Middle School Improvement Plan. Motion passed 5-0.</u>

II. C.1. Superintendent Search Process

Ms. Imbriano and Mr. McGowan, members of the Superintendent Search Committee provided an update on the search process and progress.

II. D.3. Update: Policy Handbook; NRMS and NRHS

Superintendent Bernard and Ms. Imbriano, who serve as members of the Substance Abuse Coalition (SAC) of the Community Impact Team (CIT), provided an overview on a proposal that has been drafted by a subcommittee of the SAC and which is hoped to be included in the policy handbooks for North Reading Middle School and North Reading High School for 2019-2020. The Committee discussed the proposed policy "Students to be Found in the Presence of, in Possession of, or Under the Influence of Alcohol (...)"

The Committee voted on a motion by Mr. Pappavaselio and seconded by Mr. McGowan to accept this policy as written. The motion was defeated 4-1 (Ms. Imbriano voted yes).

II. D.4. Food Service Workers Collective Bargaining Agreement

Mr. Connelly (Director of Finance and Operations) presented the terms of the tentative agreement reached with the Food Service Workers of the district. The salient points of the tentative agreement include....

- A three-year contract (July 1, 2019 to June 30, 2022)
- Adjustments to a clothing allowance that reflects the purchase of uniform tops for employees by the school district
- Professional development offerings to the Food Service Workers on days that other staff receive professional development
- The establishment of a Joint Compensation Subcommittee
- The establishment of a "Floater Stipend"
- Cost of Living Adjustments (COLA) as follows:
 - o Fiscal Year 2020: 2.5%
 - o Fiscal Year 2021: 3.0%
 - o Fiscal Year 2022: 2.5%
- Function Hourly Rates as follows:
 - o Fiscal Year 2020: \$20.00
 - o Fiscal Year 2021: 3%
 - o Fiscal Year 2022: 2.5%

Mr. Connelly offered his appreciation to Mr. Buckley, as a representative of the School Committee, for his participation in the negotiations with the Food Service Workers.

Mr. Buckley and Mr. Connelly offered their compliments to the Food Service Workers for their cooperation during the negotiations.

<u>The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to approve the Food Services Workers Collective Bargaining Agreement. Motion passed 5-0.</u>

II. E.1 Minutes:

The Committee voted on a motion by Ms. Imbriano and seconded by Ms. Boutwell to approve the May 13, 2019 Open Session minutes (School Committee Workshop) as written. Motion passed 5-0.

II. E.2. Budget Update:

Mr. Michael Connelly, Director of Finance and Operations, reported on a proposed to increase school lunch prices for 2019-2020.

The Committee voted on a motion by Ms. Boutwell and seconded by Mr. McGowan to approve an increase in Type A lunch prices by .25 at the elementary, middle school and high school levels for the 2019-2020 school year. That increase will make the elementary lunch price \$3.00 and the Middle School and High School lunch price \$3.25. Motion passed 5-0.

Mr. Connelly also provided a report on the use of the "My School Bucks" program.

Jon Bernard announced that Jessica Blanchette was hired as the new Hood School Nurse.
