I. Call to Order Open Session

Chair Scott Buckley called the Open Session to order at 6:31 PM.

II. A. Public Input:

II. B. Student Report:

Ms. Bridget Grew, Class of 2020, presented the Student Report.

II. D.1. Update: COVID-19 and North Reading Schools

Dr. Daly updated the committee on the district's response to COVID-19. Mr. Connelly and Dr. Daly provided updates on other aspects of district business during this time.

II. D.2. June 8, 2020 Annual Town Meeting Warrant Articles

Dr. Daly presented recommendations for changes to the articles to be submitted for the June 8, 2020 Annual Town Meeting Warrant. The following Town Meeting Articles were discussed and approved by the School Committee:

Lease of Land/Rooftop Space for Solar Photovoltaic Facilities

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to approve the proposed Article regarding the Lease of Land and Rooftop Space for Solar Photovoltaic Facilities as presented. Motion passed 5-0 on a roll call vote.

Electricity Supply/On-Bill Credit Purchase Agreements (Majority Vote)

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to approve the Article regarding Electricity Supply/On-Bill Credit Purchase Agreements as presented.

Motion passed 5-0 on a roll call vote.

Agreements for Payments in Lieu of Taxes (Majority Vote)

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to approve the Warrant Article regarding Agreements for Payments in Lieu of Taxes as submitted.

Motion passed 5-0 on a roll call vote.

II. D.3. NEC Board

Dr. Daly reviewed the recommended Articles of Agreement for the Northshore Education Consortium. The three proposed changes are 1. Admission of Pawtucket Regional School District as a member, 2. Amending language to create a "superintendent only" board, 3. Amend language regarding responsibilities of board members.

The Committee voted on a motion by Mr. Pappavaselio and seconded by Mr. McGowan to adopt the amended changes to the Articles of Agreement for the Northshore Education Consortium. Motion passed 5-0 on a roll call vote.

II. D.4 SOA Updates

Dr. Daly presented his comments to the DESE's commitment request for the North Reading Student Opportunity Plan: SY 2021-2023.

The Committee voted on a motion by Mr. Pappavaselio and seconded by Mr. McGowan to approve the district plan for the Student Opportunity Act. Motion passed 5-0 on a roll call vote.

• Digital Literacy and Computer Science Grant

Dr. Downs worked on a grant with the DESE for Digital Literacy and Computer Science and the district was awarded the amount of \$13,440.00.
