Call to Order Open Session I.

Chair Scott Buckley called the Open Session to order at 6:03 pm.

II. **Executive Session**

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. McGowan, pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to enter into Executive Session to discuss the Memorandums of Agreement with union personnel and to return to *Open Session. Motion passed 3-0 on a roll call vote.*

Chair Scott Buckley reopened the Open Session to order at 6:32 PM.

II. B. **Student Report** – There was no student report.

II. **CORE Measurements Survey Administration D.1.**

Ms. Amy Luckiewicz, Drug Free Communities Grant Director, gave a presentation regarding a survey that is to be administered to students in grades six through twelve in order to gather information needed to fulfil identified requirements of the Drug Free Communities Grant. This is the fifth year of the survey.

The Committee voted on a motion by Ms. Imbriano and seconded by Mr. McGowan to accept the administration of the CORE Measurements Survey as presented by Ms. Amy Luckiewicz. Motion passed 3-0 on a roll call vote.

II. D.2. Presentation: Special Education Parent Advisory Council (SEPAC) and Student Services

SEPAC receives its statutory authority from Chapter 71B, Section 3 of the Massachusetts General Laws. This authority is also codified in the Code of Massachusetts Regulations (CMR), 603 CMR 28.07 (4). The Chairperson of the SEPAC makes an annual report to the School Committee.

North Reading SEPAC Chairperson, Mr. Steve McManus, provided am update regarding the SEPAC's accomplishments in 2019-2020 as well as an overview of plans for the future. Ms. Cynthia Conant, Director of Student Services was also in attendance.

Mr. McManus will be stepping down as Chairperson at the end of the 2019-2020 school year. Dr. Daly, Ms. Conant and the School Committee members all thanked Mr. McManus for his dedication and hard work he has done with North Reading SEPAC.

II. D.3. Update: COVID-19 School Closure Update

Dr. Daly updated the Committee on the district's continued response to COVID-19 and school closure. The Central Office employees will be coming back on a staggered schedule beginning Monday June 8, 2020. Dr. Daly is wanted to for a Reopening Taskforce to prepare for the fall reopening.

Agreements with Bargaining Units

The following Memorandums of Agreement and Memorandums of Understanding between the NRPS Custodians, Paraprofessionals and Food Service Employees were approved.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano to accept the Agreement outlined in the letter from Dr. Daly, between the North Reading Public Schools and the North Reading Food Services Associates. Motion passed 3-0 on a roll call vote.

II. D.4. Fiscal Year 2021 Budget Vote

Dr. Daly and Mr. Michael Connelly, Assistant Superintendent of Finance and Operation, gave an update of the status of the Fiscal Year 2021 budget. The Public Hearing on the Fiscal Year 2021 Budget for the North Reading Public Schools was held on April 13, 2020. The budget presented reflects the most recent revenue plan from the Financial Planning Team for presentation at the June 29, 2020 Town Meeting.

The Committee voted on a motion by Mr. McGowan and seconded by Ms. Imbriano that the School Committee approve and adopt the final FY21 School Operating Budget of \$32,526,778 representing an increase of 2.4% or \$769,005 over FY20. Motion passed 3-0 on a roll call vote.
