Student and Parent(s)/Guardian(s) understand and agree that if Student requires hospitalization or other medical treatment as a result of the Student's use of the Center, the School cannot and does not assume any legal responsibility for payment of any costs associated with such hospitalization or medical treatment. Student and Parent(s)/Guardian(s) release the School and the Town of North Reading and its School District, the School's teachers, staff employees, agents and chaperones from all responsibility and liability for any injuries, illnesses, claims, damages, charges, bills and/or expenses Student and Parent(s)/Guardian(s) may incur as a result of Student's use of the Center.
