I. Executive Session

At 6:30 p.m. the Committee voted on a motion by Mr. Webster and seconded by Mr. Bowers pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session for the purpose of ongoing discussion related to collective bargaining and to return to Open Session. Motion passed 4-0 on a roll call vote.

At 6:58 p.m. the Committee voted on a motion by Mr. Bowers and seconded by Mrs. Imbriano to return to Open Session. Motion passed 4-0.

II. Call to Order Open Session:

Chairman Venezia called the meeting to order at 7:00 PM.

III. A. Public Input:

No public input at this time.

III. B. Student Report:

Mr. Jenson Kaithamattam gave the student report and presented his class work.

III. D.1. E. Ethel Little School Presentation:

This was the fourth of five presentations held in the schools across the district this year. Ms. Christine Molle, Principal, and student and staff of the Little School provided a program that included 5th Grade Science Fair presentations, a Cross-Curricula presentation (Technology/ELA/Music/Art) and a Musical Presentation.

III. C.1. MSBA/SSBC Update:

- a) Final site trailer relocation away from the Northwest corner of the site to make available the location of the future tennis courts is complete.
- b) Site work resumed in earnest west of the main entrance at Building C. Granite curbing has been delivered on site and installation has begun.
- c) Building E second story has progressed to the point where ceiling grids are in place and many lights and electrical fixtures are installed.
- d) Building E first story has wallboard up, taped and painting has begun. A portion of the Building F perimeter classrooms have been wallboarded and taped.
- e) The roof was buttoned up and continues to progress towards 100% completion with detailed finished, particularly at and around the clear story structure taking place presently.
- f) All roof top AHUs (air handling units) are installed and the exterior window installation is essentially complete (except where being used for access).
- g) The central office will move from the current Middle School to temporary space in the High School on June 1, 2015.
- h) The next regular meeting of the SSBC is scheduled for April 14, 2015 and again on April 28, 2015.

III. C.2. Fiscal Year 2016 Budget:

The Public Hearing on the Fiscal Year 2016 Budget for the North Reading Public Schools was held on April 6, 2015. The School Committee discussed the information that was presented including available revenue and the current deficit in the proposed budget, and the questions posed by the public. At this time the School Committee is supporting the current budget to see if more money becomes available from the state or town. Mr. Webster recommended that this current FY16 Budget be moved forward for approval at the April 27, 2015 meeting.

IV. D.2. 2014-2015 School Committee Evaluation:

Mr. Webster and Mrs. Imbriano, designees of the School Committee's Evaluation Subcommittee, met with Superintendent Bernard on April 7, 2015 to develop a schedule for completing the School Committee Evaluation. The self-evaluation documents were distributed and are to be returned to the subcommittee by April 27, 2015. Below is the proposed schedule.
