I. Call to Order Open Session:

Chair Janene Imbriano called the Open Session to order at 7:00 PM.

II. A. Public Input:

No public input at this time.

II. B. Student Input:

Jerlin Kaithamattam, Class of 2018 provided the student report and presented her class work.

II. D.1. Presentation: Middle School Performing Arts Students

Ms. Carla Lister, Performing Arts Teacher and Curriculum Specialist, and students of the Middle School Performing Arts program, entertained the School Committee and members of the audience with performances from the upcoming Middle School musical, "Bugsy Malone, Jr.".

II. D.2. Presentation: Batchelder Elementary School

Tonight was the second of the five school presentations to be made to the School Committee in the 2015-2016 school year. Mr. Sean Killeen, Principal, and members of the Batchelder school faculty and students made a presentation to the School Committee.

II. D.3. Discussion: Creating a Safe and Supportive School Environment

A discussion was held with the School Committee and various North Reading residents regarding the subject of "Creating a Safe and Supportive School Environment" in all schools. This was prompted by a letter (dated November 16, 2015) that the Superintendent and Assistant Superintendent authored and sent to State Representative Brad Jones and State Senator Bruce Tarr outlining the school district's experience with implementing G.L. Chapter 76, Section 5 enacted in 2012 which recognizes "gender identity" as a protected class. Several community members addressed the School Committee to express their opinions on the matter.

II. D.4. Bus Transportation Bid Results

Mr. Connelly, Director of Finance and Operations reviewed the results of the bids received for bus transportation. After the review, the School Committee voted to award the bid to North Reading Transportation.

The Committee voted on a motion by Mr. Bowers and seconded by Mr. Webster to award the school bus transportation contract to North Reading Transportation, Inc. for three years from July 1, 2016 to June 30, 2019. Motion passed 5-0.

II. D.5. Superintendent's Contract

The School Committee reviewed the updates to the Superintendent's contract and voted to accept the updates as follows:

- i. A 2% cost of living adjustment (retroactive to July 1, 2015) for the period July 1, 2015 through June 30, 2016;
- ii. A two-year extension of the contract. The length of the contract will extend through June 30, 2019 (the term currently expires June 30, 2017).

The Committee voted on a motion by Mr. Venezia and seconded by Mr. Webster to approve the updates as mentioned above to the Superintendent's contract. Motion passed 5-0.

II. F.2. Administrative Report:

- MIIA Grant Awards: The Superintendent, in collaboration with the Assistant Superintendent and the Town Administrator, applied for and received a grant from the MIIA in the amount of \$5,000.00 to be used to enhance school safety and security protocols in the district.
- Little School Roof Replacement Project Update: The Superintendent and the Town Administrator engaged in a series of conference calls during the week of January 11, 2016, with the Massachusetts School Building Authority's (MSBA) designated liaison for the project along with our assigned project manager and architect to review one final time the budget for the project. This was done in preparation for the MSBA Board as it is scheduled to take action on the proposed project at its Board meeting on January 27, 2016. The only adjustment made to the budget is an extension of project management services from 14 weeks to 17 weeks with a shift of \$10,000 from the "soft cost contingencies" line item. There was mutual agreement that this was a prudent action.
