## I. Call to Order Open Session:

Chair Cliff Bowers called the Open Session to order at 6:33 PM.

#### II. Executive Session

At 6:34 p.m. the Committee voted on a motion by Mr. Webster and seconded by Mr. Venezia pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session to discuss ongoing negotiations with the North Reading Food Service Workers, and to reconvene in Open Session. Motion passed 4-0 on a roll call vote.

At 6:51 p.m. the Committee voted on a motion by Mr. Webster and seconded by Ms. Koepke to return to Open Session. Motion passed 4-0.

## II. D.1. Presentation: E. Ethel Little School Faculty and Students

Tonight represented the fifth of five School Committee meetings held in the schools across the District in the 2015-2016 school year. Ms. Christine Molle, Principal, and students and staff of the E. Ethel Little School gave a presentation to the School Committee and the public.

## II. D.2. Presentation: Middle School Research Project/Climate Study

Ms. Catherine O'Connell, Principal of North Reading Middle School, presented a proposal for a Research Project/Climate Study to be conducted at North Reading Middle School from June, 2016 to June, 2017. Adherence to Policy ICC - Research will be observed. This is an "opt-in" study.

The Committee voted on a motion by Mr. Venezia and seconded by Ms. Imbriano to approve the Research Study at the North Reading Middle School during the 2015-2016 and 2016-2017 school years. Motion passed 5-0.

## C.1. MSBA/SSBC Update:

- a. Binder paving completed at both lower parking lots and sidewalks; final coat to be applied during the week of May 23<sup>rd</sup>
- b. Flow testing of landscape drainage under athletic and softball fields at the site of the former high school was conducted and results have proved positive
- c. Hydroseeding slope of softball field and installation of erosion mat is nearing completion
- d. AV Update: A meeting was held on May 18<sup>th</sup>; an additional meeting and comprehensive training session is set for June 15, 2016
- e. Flagpole light update; set for completion during the week of May 23rd
- f. The next SSBC meeting is scheduled for June 14, 2016.

## II. C.2. Second Reading: Policy JC - Student Behavior Code

The Committee conducted a second reading of Policy JC/JC-R: Student Behavior Code.

The Committee voted on a motion by Mr. Webster and seconded by Mr. Venezia to approve the second reading of Policy JC/JC-R: Student Behavior Code as written. Motion passed 5-0.

## II. D.3. Presentation: Foreign Language Program Superintendent's District Improvement Goal #1

Pursuant to a request of the School Committee at the May 2, 2016 School Committee Meeting, Superintendent Bernard presented an envisioned, comprehensive Foreign Language Program that is desired for the Middle School and that supports the objectives of the school district's strategic plan, "NRPS 2021: A Strategy for the Future."

Superintendent Bernard and Assistant Superintendent, Dr. Patrick Daly provided an initial presentation on the "Global Child" program that is currently under consideration for access by North Reading elementary age students.

# II. D.4. Proposal: PAUSE and Wellness Committees' Student Wellness Survey Superintendent's District Improvement Goal #1

Dr. Patrick Daly, Assistant Superintendent and Chairman of the PAUSE (Public Awareness and Understanding of Social Education) and Wellness Committees made a presentation on a Student Wellness Survey that the two committees are seeking to have administered to students in grades 9 through 12.

The Committee voted on a motion by Mr. Webster and seconded by Mr. Venezia to implement the PAUSE and Wellness Committee Student Wellness Survey.

Motion passed 5-0.

## II. D.5. First Reading: Policy JHAF- Athletic Fees and Co-op Teams

Mr. Webster and Ms. Imbriano reviewed the recommended changes to Policy JHAF: Athletic Fees and Co-op Teams.

<u>The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano</u> to approve the first reading of Policy JHAF – Athletic Fees and Co-op Teams as written. Motion passed 5-0.

## II. D.6. First Reading: Policy ICB – Curriculum Planning

Mr. Webster and Ms. Imbriano reviewed the recommended changes to Policy ICB – Curriculum Planning.

<u>The Committee voted on a motion by Mr. Webster and seconded by Ms.</u> <u>Imbriano to approve the first reading of Policy ICB – Curriculum Planning as revised. Motion passed 5-0.</u>

## II. D.7. First Reading: Policy IDBA (and IDBA-R) – Parental Notification Relative to Sex Education

Mr. Webster and Mrs. Imbriano reviewed the recommended changes to Policy IDBA (and IDBA-R) – Parental Notification Relative to Sex Education.

The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano to approve the first reading of Policy IDBA and IDBA-R: Parental Notification Relative to Sex Education as revised. Motion passed 5-0.

### II. D.8. Update: North Reading Middle/High School Facility Rentals

Superintendent Bernard and Michael Connelly, Director of Finance and Operations, reviewed a list of the rentals of the North Reading Middle/High School Facilities and revenues generated for the 2015-2016 school year to date.

## II. D.9. Proposal: Summer Use of the North Reading Middle/High School Fitness Facility

Superintendent Bernard proposed a fee-based program for students to access the Fitness Facility during the summer months under the supervision of a staff member to receive a stipend commensurate with the hours of operations.

The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano to approve the summer use of the North Reading Middle/High School Fitness Facility during posted hours. Motion passed 5-0.

## II. D.10. 2016-2017 Substitute Pay Rates

Mr. Michael Connelly, Director of Finance and Operations, presented a proposal for a change in the substitute pay rates to take effect beginning with the 2016-2017 school year.

<u>The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano</u> to approve the proposed pay rate changes for Substitute Teachers. Motion passed <u>5-0.</u>

## II. D.11. Recommendations for Appointment; Capital Improvement Planning Committee

Superintendent Bernard has consulted with the North Reading Town Clerk on the procedure for appointments to the town's Capital Improvement Planning Committee. Members representing the School Department are to be recommended to the Board of Selectmen for appointment.

The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano to recommend Ms. Julie Koepke for a term of June 1, 2016 through the end of her current term as a member of the North Reading School Committee (Ms. Koepke's term as a member of the Capital Improvement Planning Committee expires on May 31, 2018). Motion passed 5-0.

The Committee voted on a motion by Mr. Webster and seconded by Ms. Imbriano to recommend Mr. Michael Connelly for a term of July 1, 2016 through June 30, 2019 (Mr. Connelly's current term as a member of the Capital Improvement Planning Committee expires on June 30, 2016). Motion passed 5-0.
