I. Executive Session

At 6:35 p.m. the Committee voted on a motion by Mrs. Imbriano and seconded by Mr. Bowers pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session for the purpose of contract negotiation discussions and pending litigation and to return to Open Session. Motion passed 4-0 on a roll call vote.

III. B. Student Report:

Mr. Zachary Mullin-Bernstein gave the student report and presented his class work.

III. C.1. MSBA/SSBC Update:

- a) Roof installation was completed on March 19th, less detailing work. The building is weather tight.

- c) Installation of mechanical systems continues through the one-story E and F buildings.

- f) Connections for ductwork and electrical systems to the roof top equipment are ongoing since being set two weeks ago.
- g) The next regular meeting of the SSBC is scheduled for March 24, 2015.
