#### I. **Call to Order Open Session:**

Chairman Webster called the meeting to order at 6:30 PM.

#### II. **Executive Session:**

At 6:31 p.m. the Committee voted on a motion by Mr. Bowers and seconded by Mrs. Imbriano pursuant to Massachusetts General Laws, Chapter 30A, Section 21, to go into Executive Session to discuss strategy with respect to collective bargaining and to reconvene in Open Session. Motion passed 4-0 on a roll call vote.

At 7:00 p.m. the Committee voted on a motion by Mr. Bowers and seconded by Mrs. Imbriano to return to Open Session. Motion passed 4-0 on a roll call vote.

A moment of silence was observed for Arthur J. Kenney, 97, who died on March 12, 2014. Mr. Kenney served as the principal of North Reading High School from 1964-1981 and the school's athletic field was named in his honor.

Madison Capezzuto provided the student report and presented her class work.

## **III.** D.1. Food Service Program Evaluation Presentation:

Mr. Connelly, Director of Finance and Operations was charged to evaluate the existing Food Services Program. In doing so, an RFP was developed to explore three program models. Mr. Connelly presented the results of that evaluation to the School Committee for discussion and vote. Food Services associates attended the meeting and made their recommendations on keeping the program as it is with Chartwell's, with the Food Services associates being employees of North Reading Public Schools.

The Committee voted on a motion by Mr. Venezia and seconded by Mrs.

Errichetti to award the Food Service Contract to Chartwell's Management with the understanding that to be renewed, Chartwell's will need to meet the Benchmark set in year one. Motion passed 5-0.

# III. D.3. & D.4 Bullying Prevention and Intervention Plan Presentation and Curriculum/Instruction/Assessment Presentation:

Dr. Patrick Daly, Director of Academic Services presented a combined presentation on the implementation of the Bullying Prevention and Intervention Plan as well as a status update on the various curriculum, instruction, and assessment initiatives that took place across the District this year. This presentation coincides with the School Committee Goals Action Plan for 2013-2014 as follows: Leadership and Governance Goal-Policy Strategy and the Educational Program Goal-Curriculum, Instruction, Assessment Strategy, Professional Development Strategy.

- a) The last SSBC meeting was held on March 11, 2014.
- b) Administrative Tour: On March 18, 2014 OPM Jeff Wetton conducted a tour for elementary and middle school administrators, Geoff Simmons, Carl Nelson, Dr. David Troughton, Maureen Vacca, Mr. Bowers, Mr. Venezia and Mr. Webster. It was awesome!
- c) Construction Update: Tile in the toilet rooms and locker rooms as well as ceiling tiles in the classrooms, halls, and the administration offices is under installation, the auditorium ceiling is painted, rooftop units are set, the mechanical is roughed in, and the potholes on Sherman Road are filled in. The road will be repaved in the summer.
- d) Design Update: The focus is on finishes and FF&E
- e) Invoices were approved. At the next meeting there will be a full budget update presentation.
- f) Mr. Ed McGrath request to be included in the decisions regarding recycling when the first moving phase takes place this spring. The Superintendent will schedule a meeting with the OPM, The Principals, the Supervisor of Buildings and Grounds, and Mr. McGrath to address the topic.
- g) The next SSBC meeting is scheduled for March 25, 2014.

Based on those actions, a space has been identified to keep the half-day kindergarten program at the Hood School next year.
