Pending appropriation of funds, the bleachers could be installed as early as May of 2024 and the School Department is looking for interested sponsorships for sign space on the new bleachers for a fixed three-year period.

All bids must be received by Friday, April 26, 2024 no later than 11:00 a.m. All bids will be publicly opened and read at that time at the 189 Park Street address. All prospective bidders are invited to view the location of the bleachers at the Middle/High School Carey Park at 189 Park Street, North Reading, MA 01864 on Friday, April 19, 2024 at 2:00 p.m.

The North Reading Public Schools reserves the right to reject any or all bids, or to accept any parts thereof, which it considers most advantageous to the Town of North Reading.

All bids will be publicly opened on April 26, 2024 at 11:00 am, in the North Reading Public School Business office at 189 Park Street, North Reading, MA 01864.

Bid Deadline

Each bid shall be made on the form(s) attached herewith. No bid received after the time established for the receipt of bids will be considered, regardless of the cause of delay in the receipt of any such bid.

Action on the award will be taken within 72 hours following the date set for the opening thereof. The successful bidder will have 48 hours after notification of the award to deliver a certified; bank or treasurers check made payable to the North Reading Public Schools for the award amount to the 189 Park Street address. Failure to deliver such payment by the required deadline will void the bidder's proposal and the bid will then be awarded to the next highest bidder. Upon receipt of payment, the North Reading Public Schools will provide final proof of the sign design to the successful bidder(s). The District is seeking sponsorships for the new bleachers and will accept the highest bidders assuming all other conditions are met.

1.05 Sponsorship space is available for a three-year term. The sponsorship would include space on the bleachers as well as announcements of the school partnership and recognition at all home baseball games.




1.06	The new bleachers are intended to be ordered and installed during the late Spring (May/June) of 2024 and will be in new condition.	Condition
